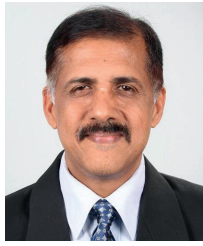




## Message from the Secretary General

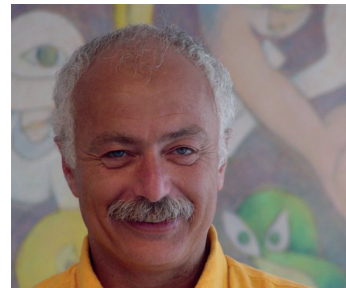

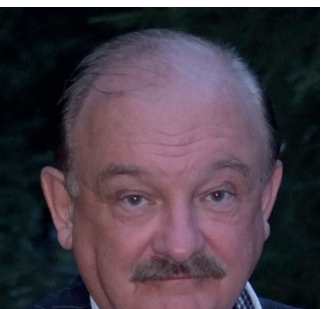

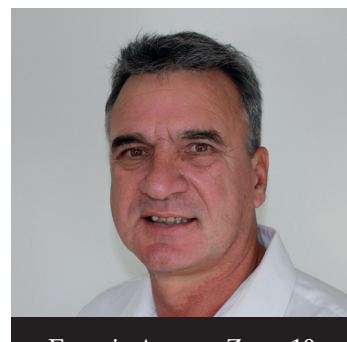

## ■ PARADOXES OF PSYCHIATRY 2015

Over the past five decades psychiatry as a discipline showed a remarkable tolerance to the paradoxical development of its tenets. Psychiatry – if it wants to survive as a respectable part of medicine - will have to deal with these paradoxes of which I am listing three here, to stimulate thinking

about them and about the many others in the provision of care for the mentally ill.

Community care has been promoted as the most effective and humane form of care for people with mental illness. Its principle is that people with mental illness should stay with their families and remain members of their communities while receiving evidence based and appropriate treatment for their illness. Another principle is that health workers involved in care for the mentally ill should be aware of the cultural and socioeconomic characteristics of the communities in which they work and take them into account in collaborating with people who have mental illnesses in the search for the most appropriate and effective forms of care.

The paradox about this tenet lies in the fact that community care has been promoted as the best solution for all settings although

in many countries communities defined as groups of people sharing the same (geographical) territory and having mutually helpful relationships do not exist any longer or are rapidly vanishing. The geographically defined territories – particularly in rapidly growing towns - more and more frequently house people who do not know each other and have never had any mutually supportive local relationships. In many of these territories a large proportion of households – up to one third in some countries – are single person households. Families of persons living alone are often far away or do not exist any longer. In such instances there are no “natural” carers – members of families, neighbors of a long date, friends and colleagues are not within reach and do not wish - or cannot - look after the person who has a mental illness.

In other instances families exist but have – in addition to providing care to the person with

mental illness other obligations – possibly providing care for another member of the family who is ailing or for one or more small children. To ask such a family to provide care for a person with mental illness can and often does surpass their coping capacity and they break down leaving not only the person with mental illness but also other family members with impairments without any assistance. The rational way of dealing with such situations would include a thorough assessment of the family's capacity to look after a mentally ill member and then deciding whether the patient can be placed within the family, (with or without significant financial help) or not and if not what other path to take. Unfortunately thorough evaluations of family strength are rarely done; and even when they are done the results of the assessment often do not influence the decisions about the placement of patients because there are no alternatives to discharging patients to the care in the family.

The notion that appropriate and humane care for people with mental illnesses requires access to many different forms of care – community care being one of them – is however gradually emerging. It contains the understanding that, on one hand, the quality of inpatient psychiatric facilities must be improved so that they can provide adequate and humane care and that on the other hand that we should fight for the creation of other facilities (e.g. sheltered workshops) and for the legal basis which will make it possible to provide families with knowledge and money which will make it possible for them to provide care without falling apart.

Another paradox concerns the strategy of task shifting which is at present promoted as being the answer to the shortage of funds (which reflects the low priority of psychiatry), particularly in conditions of financial stringency. The logic of that strategy – which is both logical and attractive to policy makers because it eases the obligation to produce more health workers specialized in psychiatry is that in many countries in which the numbers of psychiatrists are small (but also in those in which they are numerous)

the psychiatrists' tasks should be "shifted" to other health care workers or members of the community. There is good evidence that general practitioners and other health workers can provide good care to people with mental disorders particularly if they do so in collaboration with psychiatrists. There is also good evidence that people with mental disorders often prefer to receive care from health professionals other than psychiatrists – general practitioners, nurses, specialists of branches of medicine other than psychiatrists. There are several problems which are not given sufficient attention by those who promote task shifting and in policies that have adopted task shifting as a central principle of psychiatric care. The first of these is that the majority of health workers other than psychiatrists do not wish to deal with mental illness. Their undergraduate training did not make them expect that they will deal with mental illness and their competence to do this is often minimal or lacking. The second problem is that psychiatrists often lack competence to teach others about mental illness in a manner that will be effective and acceptable. The third is that expectation that task shifting to other health professionals will not decrease the cost of treatment: in all probability it will increase it, at least until a fundamental change of the undergraduate education of health professionals takes place because of the need to invest in additional training and possibly into a system of providing incentives to health workers dealing with mental illness. Finally, the fourth is that there are tasks which cannot be shifted because their execution requires special training. Those four problems indicate that the focus of efforts to introduce a shifting of tasks in mental health care should be the reorganization of undergraduate and postgraduate training of (all) health care workers rather than simply on the reorganization of services in action today.

The third paradox concerns the increasing emphasis on the expansion of postgraduate training of psychiatry. Here the logic is also clear: the services for the mentally ill today are not sufficient because the numbers of

specialists of psychiatry who should teach other professionals and deal with mental illnesses (particularly in their severe forms) is too small. If more of them were available the services would improve. The problem with this tenet is that a large proportion of psychiatrists who have been trained in the low and middle income countries (or abroad) will not stay there: they will find the conditions of work so difficult – because of the scarcity of resources, bureaucratic pressures, leadership problems and other difficulties – that they will leave the countries in which they have been trained and in which they could do most for their populations. It would therefore seem necessary to create conditions of work which will be acceptable and train as many professionals as the country can absorb in places which are sufficiently attractive for the graduates who would therefore be likely to fulfil the roles for which they were trained. A main obstacle to an improvement of postgraduate training strategies lies in the lack of links between the plans for service development and plans for training, an obstacle that could be overcome by good will of most of those concerned.

There are many other paradoxes in the process of fulfilling the role of psychiatry particularly in the third world. The notes about the three described here are not meant as an answer and strategy to resolve them but as an invitation to think about our discipline because there are many ways in which we can make it more useful to society and we can do so if we agree how to proceed.

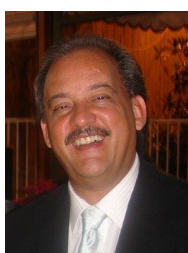

## ■ From Secretary for Finances

Dear Colleagues,

With expression of your will and by receiving more than 800 votes in the General Assembly in 2014, I was elected Secretary for Finances

of the WPA and I once again express my gratitude to all of you.

Now I expect your continued support to the WPA and the development of World Psychiatry. Together we can use this time period effectively. As you know, we have quite ambitious plans for the upcoming three years, the implementation of which will be very useful for the WPA and World Psychiatry in general.

Of course, we are actively working to ensure funding sources for that plan other than your membership fees, but fees paid by member organizations still have a role in proportion of the total WPA budget (total revenues of 30-45%).

Along with fiscal purpose, paying membership fees on time also has great moral significance.

As WPA Secretary for Finances, I can say that membership fees paid by more than 200,000 of our colleagues, who are representing 138 societies in 118 countries in the world, are good moral boosters and insure higher responsibility by lifting to a higher degree of efficiency, determination, account-

ability and transparency, which was reflected in our election plan and is now included in our Action Plan.

The cornerstones for effective work of any organization are discipline and fulfillment of undertaken duties, and it applies equally to any member, starting from those with most difficult working conditions accompanied by various disasters, wars and turmoil ending with head staff of the organization.

In today's globalized and material oriented world financial discipline is a foundation of the discipline in general.

This is the main message that I want to get to all of my colleagues around the world.

Let's make successes together.

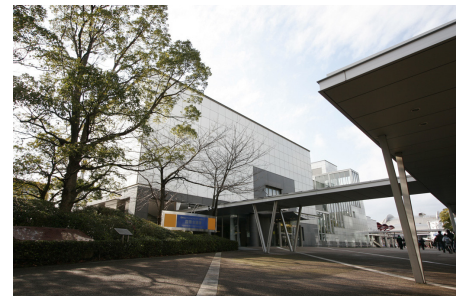

## ■ PSYCHOLOGICAL CONSEQUENCES OF TORTURE AND PERSECUTION

### Report on WPA Section on Psychological Consequences of Torture and Persecution (2013-2014)

hwail from Palestine reported on trauma on families of political prisoners, Dr. Ouanes on PTSD on former policemen subject to persecution and torture in Tunisia, Dr. Mohamed Lakhhal on the role of the psychiatrist in situations of prisoners presenting as politically motivated hunger strikers in Tunisia. Dr. Solvig Ekblad gave a paper on cultural competence required to work with refugees in Sweden and Dr. Lilla Hardy spoke of "burn-out" syndrome in service givers working with refugee victims of torture and persecution. From Hamburg, Germany, Michael Burne reported on a retrospective study on Latin American refugees suffering from PTSD and receiving psychotherapy from a non-native but competent Spanish-speaking therapist. The quality of the data and the overall scientific level of the presentations were quite

high and as it had been our target in the past few years. At the Section's business meeting in Madrid our Committee formed a subcommittee to review our Manual on Guidelines and Procedures.

Beyond the scientific program, kindness, courtesy and professional organization was the perfect mixture for the social and physical setting in which we could work productively. Madrid provided the entire cultural and social amenities one could wish for and, indeed, they left us with unforgettable memories and wishes to return soon for more.

## ■ SCHIZOPHRENIA

The WPA Section on Schizophrenia is currently revising the educational slide set which can be found on the WPA internet site at [http://www.wpanet.org/detail.php?section\\_id=8&content\\_id=130](http://www.wpanet.org/detail.php?section_id=8&content_id=130). This slide set serves as an introduction to several aspects concerning schizophrenia encompassing the clinical presentation, pathophysiological mechanisms, treatment, and case vignettes. An update is needed since the advances in all of these areas have been tremendous and this increases the workload for the

Section members, who have volunteered to revise individual sections of the slide set. In the section on clinical presentation, it will be necessary to include the new DSM-5 criteria for the classification of schizophrenia and to discuss the current developments of ICD-11. A special role will be given to early recognition of schizophrenia and the classificatory role of the attenuated psychosis symptoms syndrome. In the therapy section, both antipsychotic pharmacotherapy and psychotherapy will be revised and special attention will be given to new therapeutic developments like transcranial magnetic stimulation. In

the pathophysiology section, it will be important to review and integrate the recent progress in genetic, immunological and brain connectivity network research. Altogether, this revision will be a major undertaking and is currently in progress. For most sections of the slide sets, suggestions for revisions have been submitted by the Section members and are currently under review. The revised set should be available by the end of the year.

## ■ URBAN MENTAL HEALTH

Universidade Eduardo Mondlane, Columbia University and Federal University of São Paulo join Efforts to Stimulate Research in Mozambique

Globally, mental disorders remain 3 of the top 10 contributors to years lived with disability among those over age 15. This is even more so in low- and middle-income countries (LMICs), where over 75% of those with mental disorders receive no care despite substantial disability, and where treatment is provided, it is rarely based on evidence-based practices and human rights violations occur frequently.

As part of an NIMH/Fogarty funded *PALOP (Países Africanos de Língua Oficial Portuguesa) Mental Health Implementation Research Training*, on February 28, 2015 a team from Universidade Federal de São Paulo (UNIFESP) and Columbia University arrived in Maputo, Mozambique for a week-long course. A previous 1-month training

took place at Columbia University in September 2014. This first international implementation research training program is focused on the development of mental health services in Mozambique and is led by Drs. Milton Wainberg and Maria Oquendo from Columbia University. It is a partnership with Universidade Eduardo Mondlane (UEM) in Maputo, Mozambique and Columbia University, in alliance with UNIFESP and the Vanderbilt Institute for Global Health. The goal of this training program is to prepare Mozambican researchers to approach the construction of

their mental health system in a rational, efficient, and effective manner. The notion is that one does not simply implement mental health programs because we hypothesize that they will work. Rather, programs are implemented such that there is an experimental design (efficacy/effectiveness trials and/or implementation trials) that permits rigorous evaluation. In that manner, scarce resources are invested only in programs demonstrated to work in the local context.

Finally, visitors were able to experience the wonderful Mozambican cuisine including its outstanding seafood, fresh from the waters of the Indian Ocean. This was a wonderful consequence of the launching of a five-year training program so that Mozambique can be a model to other PALOP and sub-Saharan African countries as well as other to low-resource settings, including the US.

## ■ WPA ZONE I (CANADA)

As the national voice of Canadian psychiatrists, the Canadian Psychiatric Association advocates for the professional needs of its members and promotes excellence in education, research, and clinical practice.

The CPA Objectives are: 1) To uphold and develop the biopsychosocial approach to the

practice of psychiatry and promote research and continuing education of members by establishing and maintaining standards of practice and facilitating maintenance of competence in the practice of general and specialized psychiatry; 2) To promote and participate in educational programs necessary for the care of persons with psychiatric disorders and the promotion of mental health; 3) To represent the profession of psychiatry to governments, universities, medical associations, licensing and certifying bodies, and other organizations with which the psychiatrists of Canada from time to time may have relationships; 4) To publish journals, newsletters and other literature for the

dissemination of knowledge regarding psychiatric disorders and promotion of mental health.

The CPA welcomes WPA members to attend our future Annual Meetings of over 1200 participants to be held in Vancouver (October 1-3, 2015), Toronto (September 15-17, 2016), Ottawa (September 14-16, 2017), and Toronto (September 27-29, 2018).

## ■ WPA ZONE 7 (NORTHERN EUROPE)

The 31st Nordic Congress of Psychiatry will be arranged in Copenhagen between 20th and 23rd of September 2015. The theme of the congress will be "Psychiatry Works". Since 2012, the Joint Committee of the Nordic Psychiatric Associations has published a journal for clinician, The Nordic Psychiatrist, in addition to the scientific journal Nordic Journal of Psychiatry. The new journal has been well received. Main concerns differ among countries in the WPA Zone 7.

Large reforms in health care funding and organization of services are underway in Finland. The deliverables of this venture remain to be seen. Specialist training will no longer be carried out under the auspices of the education ministry but moved to the social ministry. It has been planned that after 2022 each MD should apply for specialist training.

The leading principle behind this has been concern over lack of physicians in certain specialties. In Sweden there has been concern of young women with self-harm in forensic care together with sentenced forensic patients. The annual congress has been a success both financially and from the view of participants. A congress will be arranged next autumn on diabetes by the national association and researchers.

DSM-5 will be translated in Lithuania shortly. There is only one psychiatric hospital left for 2,9 million inhabitants. A working group for development of mobile crisis teams has been set up. Young psychiatrists amount to



18% of all psychiatrists in the country. Latvia has one of the lowest health care budgets in the EU. There is a brain drain of psychiatrists to other countries in the EU. New editions of national guidelines have been drafted. In Estonia work disability has been debated. Psychiatric patients have not received enough support for returning to work. Fewer physicians have applied for psychiatric residency and several positions have remained vacant.

## ■ WPA ZONE 15 (CENTRAL AND WESTERN ASIA)

### CHILDREN AS VICTIMS OF TORTURE

On the morning of 16th December 2014 terrorist attack on Army Public school Peshawar killed 147 innocent lives, leaving the families of martyred and injured in grief and pain.

The sheer scope and severity of destruction have prompted extraordinary national and international attention and support for survivors of the families of martyrs and injured on priority basis. The devastation created by the incident was catastrophic, not only for the affected families but also to those who watched TV, reliving the past traumatic events for survival of suicidal bomb blasts of the past. Those who watched the social media or print media as well resulted into an immediate acute stress and mental health sequel. The task facing the national community as it attempts to provide relief was equally extraordinary. The short-term emergency needs were enormous, and the longer-term needs for need assessment and rehabilitation have not ever been quantified.

Firstly the relief activities confronted the challenges of the disaster as a complex emergency. Secondly, the clinical and psychological profile of this disaster is not similar to that of any incident in the past. The death of children and family members was a blunt trauma, and the injuries among the survivors

arise from complications of experiencing the traumatic incident. Thirdly, the short-term public health needs of the surviving population were not familiar.

There was an urgent need for the need assessment of the people, affected in APS incident, including children, parents and other family members or relatives, identification of the PTSD symptoms, deciding for the required interventions, and initiating a support system.

The incident evoked a debate in mental health practitioners that how this huge number of affected families, and other people who are severely affected by this incident, could be assessed for their needs. This debate initiated an urgent need for the collection of information from those resources. There was a dire need to develop an objective assessment procedure to evaluate the PTSD symptoms and plan for required intervention. There was no preexisting data to be used as a guide line to deal with a disaster on such scale. This could possibly be done through approaching the effected population and try to find out the way in which they could be professionally helped, without any interference or debriefing their experience.

The public health model for disaster highlights a cycle of preparedness, mitigation, response, and recovery. It is thus crucial to consider what sorts of preparations may pre-

vent a similar disaster in the future or could possibly be used to help the sufferers. Horizon Welfare Organization has the capacity to provide several hours of early management and support services; as provided sufficient funding and will for this cause, it could be adapted and introduced throughout the country for future reference. The larger issue, however, is the development of rapid assessment, interventions, communication and support systems for such populations.

Despite the massive scale of this emergency, we need to be better prepared than ever to deal with the immediate psychological and physical health threats created by such traumas. What remains uncertain is the extent to which donors and implementers will be able to support the transition to long-term rehabilitation services. In the past, we have been far less proficient at this second crucial task. Yet we know that the need for long-term success has never been more urgent than it is now.

The Mer de Glace (Sea of Ice) is a glacier located on the northern slopes of the Mont Blanc massif, in the Alps. At 7 kilometres long and 200 metres deep, it is the longest glacier in France. 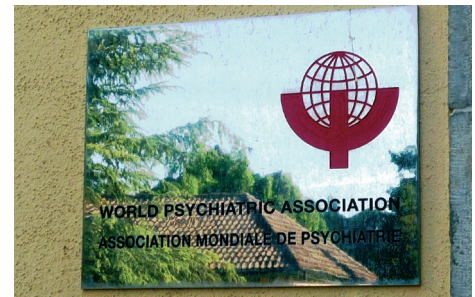
